Information for Legal Boundary Descriptions

The following information are for communities following “Option A” as described in the Data Release Packet.

Contained within this folder is a draft of the legal boundary description, which was auto-generated from a computer program, which corresponds to the wards and precincts of your draft map. This draft MUST be proofread and approved locally.

The “metes and bounds” description of each precinct boundary will use any linear description provided by the U.S. Census Bureau, therefore it is imperative that you check the language for errors against any maps and descriptions you possess. Be aware that you may encounter ambiguous terms such as ‘unnamed local road,’ and ‘invisible boundary.’ These are descriptions used as placeholders when the actual physical description is unknown to the computer program. You must update these descriptions to the best of your ability along with any other corrections to the metes and bounds report we provide you.

Defining an unnamed local road can be as simple as replacing that phrase with the actual road name. Other options for replacement could be in the form of a description such as ‘ATV Trail,’ ‘foot path’ or ‘abandoned railroad bed.’

Defining an invisible boundary can include describing a point of origin, the direction and distance of the line, and the terminus point.

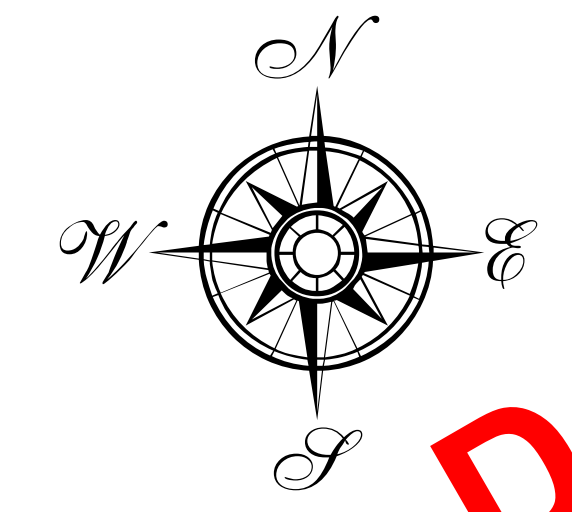
Here is a sample legal description using identifiable streets: *“Starting at Maple Street and proceeding easterly along Main Street to the northerly extension of Woodlawn Avenue, and proceeding southerly along Woodlawn Avenue and its extension to the intersection of Tyler Street; and proceeding westerly along Tyler Street to the intersection of North Street, and proceeding...”*

Here is a sample legal description using geography as the origin and terminus points along a line: *“Beginning at Ray’s Point, proceeding northeasterly for a distance of 1,000 feet, and northerly for a distance of 800 feet, to the mouth of the Jones River, and proceeding easterly along the Jones River to...”*

Here is a sample legal description using an invisible boundary: *“and proceeding southerly, westerly and southerly in the Pittsfield-Hancock town line to Hawthorne Brook extended westerly; and proceeding easterly along the extension of Hawthorne Brook to the west end of Hawthorne Brook; and proceeding southeasterly along Hawthorne Brook to the intersection of Cascade Street, and proceeding...”*

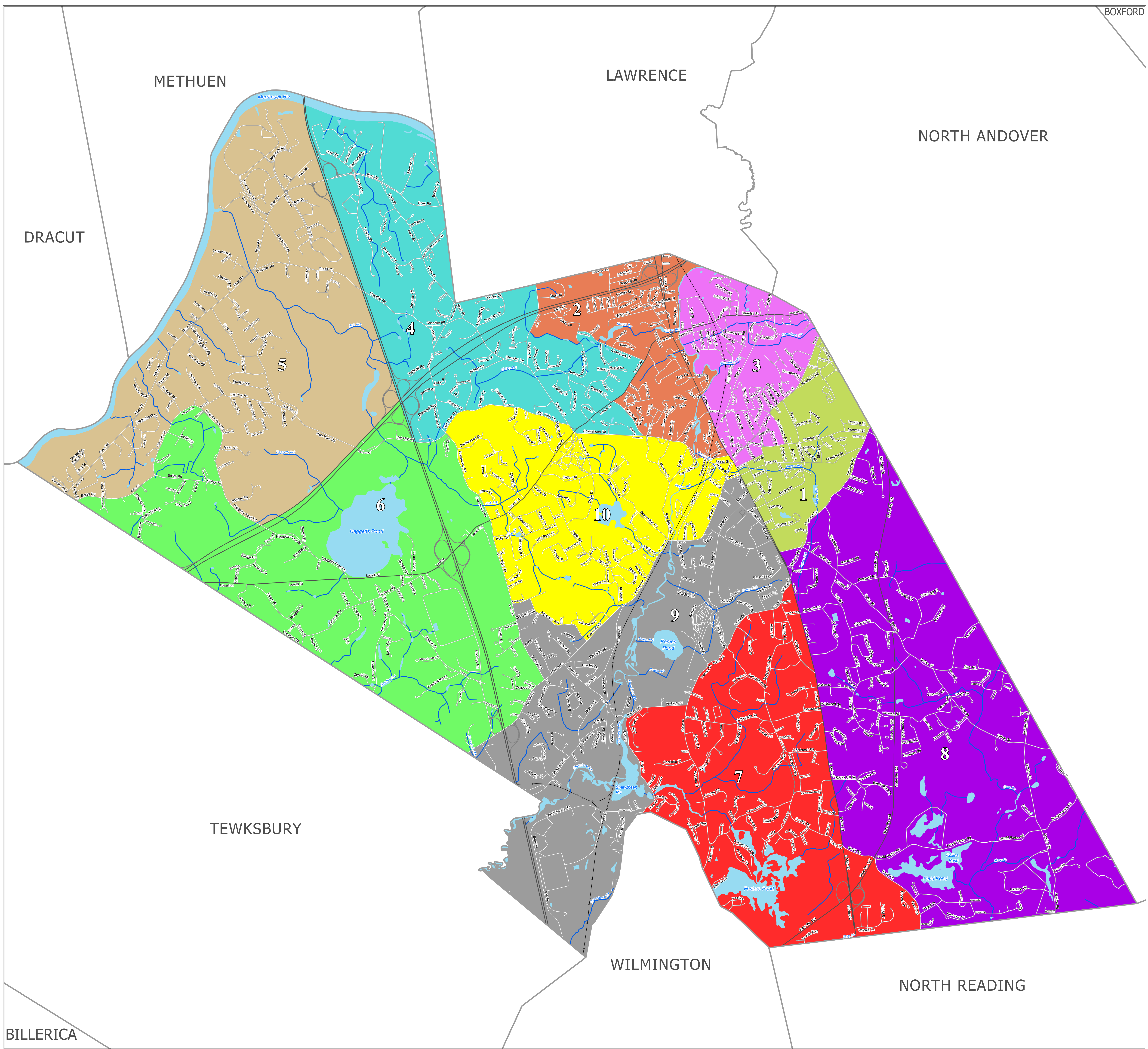

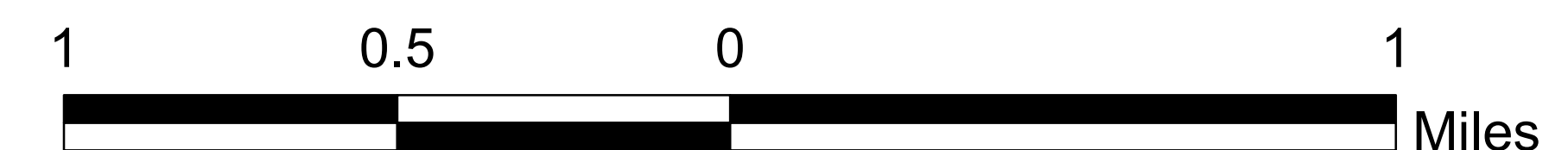
